Region 14 Show Approval Meeting October 1, 2022 at 7:00 PM via ZOOM

Jeff Caldwell led this meeting, with 13 of 19 delegates and 3 guests present. The main topic was approval of several 2023 shows either to be held in Region 14 or as qualifiers for Region 14.

Jeff read a letter from Duane Esser, who was unable to attend the meeting. Duane feels that having the WEC-Ohio facility in our region is one of the reasons that Region 13 is requesting approval of their regional Sport Horse Championship show, their regional Pre-Show and their regional Championship show be held there. He feels that all these shows are good for our region.

Cindy Clinton was pleased to report that the Silverama / Region 14 show was very successful, with the change of venue to WEC-Ohio and the date changes to August $17^{th}-21^{st}$. This way we are not competing with the June dates of Region 13 and the July dates for Mid-Summer / Youth Nationals. The only AHA show being held at that time in August was to be Canada but it was postponed again this year.

Cindy Ryan reported that the concurrent Medallion show, held June $11^{th} - 12^{th}$, was successful, with 118 horses (vs. 65 in 2021) and they had 67 dressage rides, including 21 in Western Dressage. They also sold all their TBA slots. She noted that a few exhibitors stayed over to show at the Region 13 Sport Horse show. Jennifer Lewis noted that the Medallion show was a qualifier for Region 13. Next year they will be hiring a large R judge for dressage.

Motion #1:

Joe Hull moved and Cindy C seconded a motion to approve all three of the following: Region 13 Dressage/Sport Horse Offsite Championship (June14-17), Region 13 Pre-Show (June 20) and Region 13 Championship (June 21-25) for 2023. This was passed by the delegates. Jeff requested that Joe draft a letter to Ann Knoop, Region 13 Director, affirming these results.

Motion #2:

Cindy R moved and Cindy C seconded a motion to approve the Medallion A and B Concurrent shows (June 10-11) for 2023. This was passed by the delegates.

Motion #3:

Cindy C moved and Joe seconded a motion to approve the Elimra Arab and Sport Horse Classic B Concurrent show (May 26-28) for 2023. This show is an offsite qualifier for Region 14, held in upstate New York and has no impact on the Buckeye show. This was passed by the delegates.

Joe also wanted to remind those at this meeting that for the delegate (Early Bird) packet reimbursement, the delegate must have attended either two (2) Region 14 meetings OR one meeting and volunteered at one budgeted Region 14 event PLUS they must attend the regional caucus meeting and be present at the beginning of the convention's General Session on Saturday morning. If paid by credit card, the cost is \$225 + \$6.75 (3% convenience fee) for a total of \$231.75. Please send a copy of your receipt to Joe.

Jeff read a list of all the Region 14 shows that are approved for 2022-2023. He will email this list to Debbie Swigart who will put out an eBlast, and also update the regional website.

Cindy C moved and Jennifer Tucker seconded a motion to adjourn the meeting.
